# Section 5. Fire-fighting measures

#### **Extinguishing media**

Suitable extinguishing media

### Specific hazards arising from the chemical

: Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. # Appropriate engineering controls
